I was selected and became a Criminal Investigator in Carlsbad, New Mexico in June 1997. Since that time I have worked with the Pecos Valley Drug Task Force, a HIDTA initiative. My primary duties were to locate and apprehend Criminal Aliens that are not incarcerated within our seven counties of operations. I was also on call one week each month to respond to Border Patrol call-outs related to alien smuggling. I have taken a Category 1 alien smuggling case from the apprehension to the sentencing in Federal District Court. I have apprehended and been the case agent on several re-entry after Deportation cases. I was called upon daily to use my knowledge of the Immigration and Nationality Act, laws, operational procedures and regulations dealing with aliens, both legal and illegal. I applied this knowledge to establish facts as to citizenship, legal residence status, and for prosecution of criminal violations.

With my knowledge of exclusion and removal, I searched court records and Probation list for Criminal aliens who have committed crimes that would violate their status. I would then locate, apprehend and process the aliens for a hearing at the Office of Immigration Review or set them up for Removal. I exercise considerable ingenuity in applying and interpreting operational instructions, service policy, sector guidelines and current court decisions in every field situation that I encounter. This includes knowledge of court procedures, evidence and testifying as a witness in court proceedings, criminal and administrative. As a Criminal Investigator in the Carlsbad, New Mexico, I communicate on a daily basis with U.S. Attorneys, Sector and District Counsel, Sector Prosecutions office, New Mexico District, Magistrate and Municipal Courts. I prepare Notices to Appear, Bond and Custody paperwork on Criminal Aliens. I have been the case agent on many re-entry after deportation cases and alien smuggling cases. I performed mainly transportation duties but on several details I was used inside Immigration Processing Centers, Federal Penitentiaries, and even Mental Hospitals.

As a Detention Officer for the Border Patrol, I had to accept custody, escort individuals or groups between a wide variety of points, including transportation rendezvous locations; airports; bus stations; courts; local jails and detention facilities; medical facilities; places of previous residence and business.
