The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendant committed the following violation of law:

On 01/29/2024 at 02:34 (Specifically include facts constituting cause for arrest.)

On January 28th, 2024, I Ofc Zwolensky #5256, while assigned as B51 responded to a vehicle crash at 928 Masterson St. Upon arrival a white Scion SUV was found at the scene with no driver. Witnesses described the driver as an older white male, grey hair, and 250 lbs. The witness said he left north on Avocado avenue on foot.

The Melbourne Police Department Dispatch was able to provide an address for the vehicle owner from the registration. An officer was dispatched to the home of Alan Parenteau (arrestee) to see if he made it back home. Officer's verified that Alan was not at the apartment and a neighbor was able to provide a cell phone number for him. The officer was able to contact Alan by the phone number provided. He would not tell police where he was when he was asked multiple times. Alan received multiple lawful commands to meet with officers and he refused to do so. Alan did tell police that he was injured and The Brevard County Sheriff's Office was contacted to use their helicopter (STAR) to search for Alan. Alan was located with the help of BCSO STAR at 3210 N Harbor City Blvd. Alan was arrested and upon searching him, was found to still have the car keys to his vehicle in his pocket.

Alan had a minor cut to his head, arm, and a bruising to his left eye from the crash. While getting him medically cleared for the injuries, he continued to say that he made a left and not a right causing him to crash on the railroad tracks.

Alan is being charged with Florida State Statute (FSS) 316.061 fleeing the scene of an accident and FSS 843.02 resisting without violence. He was issued a citation for leaving the scene (A19AUZE) and careless driving (A19AV0E).
