On March 27, 2024, I Officer Otto ID 4587 was dispatched to _____ in reference to a verbal argument between _____ Dispatch advised that there was yelling in the background while the complainant was trying to take _____ because _____ was drunk.

Officer Ethier ID 4746 arrived on scene approximately 10 minutes before my arrival and was speaking with the complainant, _____ was parked outside apartment _____ sitting inside her vehicle with _____ While Officer Ethier was speaking with _____ I spoke with Kayla Campbell (defendant) whom was standing in the front doorway of _____ While speaking with the defendant she asked me to come inside _____ to speak with her further. During our conversation, I observed the defendant to be very intoxicated. I could smell a strong odor of alcohol emitting from her breath, she was slurring her words and couldn't hold a conversation. While asking the defendant basic questions, she continued to repeat herself and not answer my questions directly. The defendant continued to repeat that _____ "can't handle this" and "needs her oxygen". The defendant in essence stated that _____ came over to _____ because she was upset and took _____ but it was ok with her that _____ had _____ because _____ love her. The house appeared to be in disarray, dishes were piled up in the sink, and an alcohol bottle was observed on the table. When I asked the defendant if she had been drinking today in a round about way she admitted to it however mentioned me speaking with her friend which I could not make sense of her answer.

After my conversation with the defendant, I walked outside to speak with _____ During our conversation, _____ made mention that _____ was attempting to grab her cell phone while she called 911 and that's how she sustained an injury to her arm. _____ had a visible bruise on her right forearm and approximately a quarter size piece of skin was pulled back and bleeding, however she denied medical and stated she did not want to press charges against _____ also mentioned that _____ left _____ alone in the house while she went to Be Backs to drink alcohol. Which according to map quest is approximately 1.4 miles away from _____ received a call from _____ to come pick her up at Be Backs. _____ however did not end up picking the defendant up from Be Back's and went to _____ inside. When _____ arrived at the apartment, the defendant was already home, she apparently was dropped off by an unknown male.

Due to the defendant's level of intoxication, _____ wanted to take _____ for safety reasons. When the _____ willingly entered _____ vehicle, the defendant came outside and entered _____ vehicle with _____ This is when the verbal argument between the two started. _____ told the defendant that she was not coming with her and if she didn't get out of the vehicle, she would call the police. _____ exited her vehicle to call 911 at which point the defendant exited the vehicle as well and attempted to grab the cell phone out of _____ hand while she was speaking with 911 in order to deprive her of communication with the dispatch. _____ however was still able to hold onto her phone. _____ stated that she could not complete a sworn written statement at this time but provided a sworn audio statement on my body worn camera.

I spoke with each to the juvenile children who advised that _____ leaves them for periods of time and doesn't tell them where she is going. _____ who was _____ was responsible for taking care of _____ the _____ While speaking to the children I noticed that none of them had shoes on. I asked all four juveniles when the last time they ate a meal and they stated not since last night, they had not eaten anything today. The _____ stated that _____ sometime in the early morning and they did not see her again until 1230 p.m. today. It should be noted that the _____ according to the defendant and _____ has been sick the past couple days, was seen by a doctor and was prescribed medication. The defendant kept advising me of how sick _____ was however she still left him _____ while she left the house to go to a bar. The approximate time the defendant left _____ unattended was from 1 a.m. to 12:30 p.m.

The defendant was read Miranda and refused to speak with me. She was placed under arrested for Battery (DV), Child neglect (4 counts) and deprivation of 911 by hindering the communication to a law enforcement officer. The defendant's criminal history revealed that she was charged with battery on 04/19/2023 however that case was dropped. The defendant was transported to the Melbourne Police Department before being turned over to the Brevard County Sheriff's Office.
