On May 29th, 2025, Maria Colon responded to Cocoa Police Department to report that Veronica Waterman was in possession of Child Sexual Abuse Material (CSAM). M. Colon stated that Veronica Waterman, who previously identified as Rodney Waterman, Date of Birth, January 20th, 1959, White, Male. M. Colon advised Veronica changed her name from Rodney Waterman and identifies as a female. M. Colon reported that Veronica Waterman (hereinafter referred to as suspect) showed her CSAM from his cellphone. M. Colon reported that she was shown two videos containing CSAM at the suspects residence located at 450 Whaley Street, Cocoa, Brevard County, Florida 32922.

In addition to M. Colon reporting that the suspect possessed and showed her CSAM, she completed a seventeen-page written witness affidavit describing concerning comments, behaviors and admission from the suspect committing sexual abuse of a child. The written affidavit includes comments from the suspect to include his desires to have sex with minor females, his attraction to minor females and his desire to kidnap a female child. The affidavit includes a description of two videos the suspect showed to M. Colon that described CSAM. M. Colon indicated in the affidavit that the suspect has expressed to her that he is a pedophile. The affidavit also states the suspect told M. Colon he traveled to Washington to have sex with a minor female several years ago. Included in the affidavit, are details of the suspect comments towards being attracted to minor females and his desires to have sex with a child if he had the opportunity.

I completed a search and criminal history for Veronica Waterman. V. Waterman was previously



identified as Rodney Waterman and had a legal name change to Veronica Leann Waterman. A criminal history search revealed a previous arrest in the State of California for Lewd or Lascivious act with a child under 14, Lewd or Lascivious act with a child under 14 and contributing to the delinquency of a minor in which Rodney Lee Waterman was convicted for contributing to the delinquency of a minor. Using additional investigative resources, I found a previous Internet Crimes Against Children Cybertip # 164002956 that was investigated by Agent Aja Stake from the Brevard County Sheriff's Office in June of 2023 under Brevard County Sheriff's Office case number 2023-00259410. I contacted Agent Stake in reference to obtaining a new report involving Veronica Waterman.

I contacted M. Colon and requested an interview at the Cocoa Police Department. On Monday June 2nd, 2025, at approximately 06:30 A.M., M. Colon responded to the Cocoa Police Department for an audio-video recorded interview. I was present during the interview along with Agent Aja Stake and Agents from the Brevard County Sheriff's Office. M. Colon stated during the interview that she became power of attorney of the suspect in March of 2025. M. Colon stated that the suspect began to show behaviors that were inappropriate to include comments towards minor children. M. Colon described an incident where the suspect approached three minor females inside McDonalds in Viera on Stadium Pkwy, who were approximately [REDACTED] and began telling the female child she was beautiful. M. Colon stated that she had to physically grab onto the suspects arm to pull him away from the juveniles. M. Colon stated the suspect continued to make comments towards the juveniles until she pulled him out of the doorway of the restaurant. M. Colon described another incident where the suspect began talking to a minor female at the Dollar Tree located on Clearlake Road in Cocoa. M. Colon stated the suspect was in the check out lane at the store and heard the cashier say "I'm a minor". M. Colon stated when she heard the girl say she was a minor, she told the suspect to stop making comments towards her. M. Colon provided further information to include comments about being attracted to minor females, wanting to have sex with minor females and went into detail about his attraction towards minor females. In another incident, M. Colon describes a conversation between her and the suspect agreeing to purchase property in Tennessee. M. Colon stated that during that conversation, the suspect talked about wanting to get a young girl and keep her in a bunker to have sex with her whenever he wanted. M. Colon provided further details

about the suspect admitting that he is a pedophile. M. Colon stated the suspect told her he traveled to the State of Washington to meet with a [REDACTED] female. She stated the suspect told her that he traveled and had sex with the [REDACTED] in Washington and then showed her a picture of who he stated was [REDACTED]. M. Colon stated that the suspect has a picture of the [REDACTED] juvenile that he had sex with on his cellphone.

In May of 2025, M. Colon stated she went over to the suspect's residence to give him a bottle of water, food and his kidney preventative medications. She stated the suspect told her that he wanted to show her something on his phone, but then stated he would show her another time. M. Colon stated that she initially thought the suspect was going to show her an Elvis music video or some other type of music that he usually shows her. M. Colon stated approximately two days later, she was back at the suspect residence and sitting with him on the porch. M. Colon stated the suspect was sitting on his rolling walker and said he wanted to show her something. M. Colon stated the suspect became upset and said, "God dammit I have to get back up again". M. Colon described the suspect getting up to retrieve his cellphone and he stated, "It's on my other phone". M. Colon describes seeing the suspect scroll through his phone and then he holds the phone in his hand and holds it up to her face. M. Colon stated she immediately realized that a was a video of child pornography. M. Colon stated she was in a shock like state and felt very emotionally distraught after seeing a video on his phone. I asked M. Colon to describe in detail what she saw on the suspect's phone. M. Colon stated she was shown a video of two minor female's who were observed standing with "panties" on. M. Colon stated both females had no shirts on. M. Colon stated the females appeared to be under 10-years of age and did not have any breast development. M. Colon stated the juveniles began to pull down their panties while posing. M. Colon stated both females took off their panties and exposed their vaginas. M. Colon described the female juvenile being completely naked and not having any pubic hair. M. Colon described the female juveniles being recorded while the posed in various positions that exposed their buttocks and vaginas. M. Colon described the video showing a bed and described the room to be a larger bedroom. M. Colon stated the video was approximately two minutes long and both female juveniles were smiling. M. Colon described another video the suspect showed her from his cellphone. M. Colon stated a female juvenile was completely naked and was



standing in a bathtub. M. Colon stated the girl in the video appeared very scared and appeared to be in a "frozen state".

M. Colon stated after she was shown the videos, she was very upset, angry and unsure how to maintain her composure. M. Colon stated that after she saw the videos, she wanted to report this information to the police. M. Colon stated that she wanted to gather more information and asked the suspect who sent him the videos. The suspect described obtaining the videos using Telegram. M. Colon stated the suspect told her he uses Telegram because the application is encrypted, and he is allowed to have the videos as long as he doesn't share the video with anyone. M. Colon stated the suspect told her that Telegram is "super encrypted" and that even law enforcement can't get information from Telegram with a subpoena. M. Colon stated the suspect began to make comments about the videos and stated, "You saw how much they fucking love it". M. Colon stated she told the suspect the girl in the second video did not appear to be smiling. M. Colon stated the suspect replied "Yeah, the two girls loved it, they enjoy it, maybe not the other girl, she just needs to get used to it". M. Colon stated she became very upset and had to leave the suspect's residence.

M. Colon described the cell phone that she was shown video's containing CSAM as an Android phone with a Wonder Woman design. M. Colon described the phone as having various images of Wonder Woman on the exterior of the phone. M. Colon was unsure if the videos were saved on the cell phone.

On June 17th, 2025, a residential search warrant was executed at Veronica Waterman's residence, located at [REDACTED]. V. Waterman was in possession of the black in color Android Cellphone with Wonder Woman stickers. V. Waterman was read the Miranda Warning and agreed to speak with me. V. Waterman admitted he has viewed young females, that he estimated to be [REDACTED] using his cellphone and other devices. V. Waterman admitted to receiving photographs and videos of minor children without clothing. V. Waterman admitted to receiving various photographs and videos from social media applications such as Instagram, Telegram and

Waterman admitted to traveling to Washington State to meet a juvenile female whom he referred to as [REDACTED] approximately 15 years ago and stated he traveled from Florida to Washington in 2008. V. Waterman believed [REDACTED] to be approximately [REDACTED] V. Waterman admitted to only meeting with [REDACTED] and denied any physical contact with [REDACTED] V. Waterman admitted to looking at young girls on his cellphone's and stated that he does have pictures and videos on his devices. V. Waterman stated has used cellphone's, a laptop, and tablet. A search of the residence was completed. During the search, an HP Laptop, a Blue tablet, a Samsung Smartphone, a Vortex Smartphone, and an Android cellphone were taken into custody by the Cocoa Police Department. The devices were transported by Kirsten Griffith, a Crime Scene & Evidence Technician with the Cocoa Police Department.


