on May 6, 2024, Mark Senti (deceased), was brutolly attacked by Gavin Smith and Warrick Smith at Ichobods Dockside in Helboume, FL. The entire incident Was captured on Video surveillance. As a result of this offock, Mork Sonti Suffered severe injuries including a broken jaw and framatic brain injury and brain bleed. On January 11, 2025, Mark Sonti succumbed to his injuries and died. His body was found in the Melbourne Harbon Marina.

The Helbourne Police Deportment grassly hishandled the criminal invertigation into the May 6, 2024 incident and Mr. Senti's subsequent death on January 11, 2025. The Melbourne P.D. failed to effect an arrest on Govin smith and Warrick Smith despite Mark Senti's wishes and intent to pursue formal charges. The Video surveillance, without statements, and severity of Mr. Senti's bodily injuries provide clear and sufficient probable cause to support arrests for Felony Bottery.

Officer Hamilton completed a capies request for bottery against blarrick Smith and additional chargest were prepared for bottery against Gavin smith; however, for reasons that remain unbrown, these charges were never firmally filed on schools of Mark Senti. The senti family mode repeated requests and efforts to communicate with the Melbourne, Police Department and privide evidence to ensure justice was pursued. Despite their efforts, they were not with silence, delay, bureaucratic indifference, and an unexplainable finding of no probable. Course by Detective Harrison. The decision to close this case as "no probable cause" in the face of clear video evidence and cooperating victims and witnesses reflects gross negligence and a complete divergard for the legal standard of probable cause.
