On the above date and time, Officers responded to the area of 684 Osmosis Dr. in reference to shooting. Information provided by dispatch stated a white SUV RAV 4 was seen shooting and had fled from the area and proceeding to DeGroodt Rd.

Upon my arrival, I just turned onto DeGroodt Rd. and observed the above vehicle driving southbound passing St. Andre. I caught up to the vehicle and proceed to follow the vehicle till it pulled into a residential driveway at 361 Titan Rd. Officers conducted a felony stop on the vehicle and two occupants were removed. In Plain view, officers observed two fire arms, a rifle in the backseat and several casing and a spent casings. The defendant was the driver of said vehicle and after waving his Miranda Warnings rights, the defendant stated he was just driving with his friend, heading to Circle K and had stopped though the neighborhood to look at Christmas Lights. But denied firing any guns. Upon speaking further with the defendant, he admitted to being in the area of Osmosis, shooting his personal handgun, through his open sunroof, firing three rounds. The defendant mentioned to wanting to "blow off steam" and knew the area known as "The Compound" was a safe and undeveloped area to shoot. The defendant admitted to being the only person shooting after buying the guns from his friend who was sitting in the front passenger seat.

Based on the above information, the defendant was arrested for discharging a firearm from a vehicle. He was transported to Palm Bay PD for booking and later turned over to Brevard County Jail Deputies.
