On Friday, November 15, 2024, while working an off duty detail at The Space Coast Daily Park located at 5775 Stadium Parkway, Melbourne, FL 32940, a medical call came out regarding a juvenile bull rider who got injured and was transported to the Holmes Regional Medical Center.

It should be noted, on Friday November 15, 2024, FTO Kirby Gobeli ID # 4906, was the deputy on scene when the medical call came out. See FTO Gobeli's supplement report for details about the incident on November 15, 2024.

On today's date, Sunday November 17, 2024 while working the same detail at The Space Coast State Fair, I was advised by Sergeant Richard Rozycki ID # 156 to conduct an investigation on the medical call due to the juvenile's medical state worsening.

I first made contact with Renato Teixeira (Involved), who is the promoter of the rodeo at the Space Coast State Fair. Renato stated the following in substance:

On Friday November 15, 2024, there was an incident where a juvenile, later identified as Walker Smith 8/14/2007 (Involved), was bucked off a bull and stepped on. Walker was trying to stay on the bull for 6 seconds and lost control and came down to the ground. The bull jumped and the back feet of the bull landed on Walker. They were able to get Walker in to the chute and away from the bull. After a few minutes, Walker was able to get up and walk on his own. He was breathing and talking like normal, answering questions and was coherent. Renato advised one of workers of the rodeo is a paramedic and was there assisting Walker until Brevard County Fire Rescue arrived.

Renato advised that he has seen Walker at other rodeo's before and he travels throughout Florida to other rodeos. Renato advised that he doesn't know what rodeo circuit Walker belongs to, he just produced an open deal event at The Space Coast State Fair and Walker was a rider. Renato is the owner of Tex Brother's Ranch in Punta Gorda, Florida.

### NARRATIVE (continuation)

I then spoke to Christopher Jones (Involved), who is a worker for the rodeo and also a parent of a juvenile participant. Christopher stated the following in substance:

The Juvenile was trying to ride the bull and as he fell down the bull was in the middle of the buck and landed on the boy's chest. They protected Walker from the bull and escorted the bull out of the arena. Walker told Christopher he did not want to get carried out, he wanted to walk out. After Walker caught his breath he was able to walk out of the arena on his own. Christopher stated that Walker's girlfriend is a nurse and was assessing him while they waited for BCFR. Christopher advised he does not know Walker's girlfriend, but knows her first name is Talor. Once BCFR arrived on scene, Christopher went back to the arena to attend to his own child who is also in the rodeo.

I then spoke to Sandra Brownlee (Involved), who is the secretary for the rodeo. Sandra stated the following in substance:

She is the Secretary who is in charge of having the liability release forms signed, and she is also the time keeper for each round of the rodeo. On Friday, November 15, 2024, Sandra remembered Walker's incident and remembered that he had a gentleman there, who claimed to be his father, sign him up for the rodeo. That gentleman signed the liability release form for Walker and for another 5 year old female juvenile. There is no name on the liability release of who signed the form for Walker and it is unknown at this time who signed it. Sandra was asked if she checks Identification for the parents/guardians as they sign the liability release forms to which Sandra stated no she does not check ID. The original liability release form signed by the guardian of Walker has been entered in to evidence at West Precinct locker 11.

I then spoke to Tyler Barnes who is the owner of the bulls at the rodeo. 6 photographs of the bull who injured Walker were taken and submitted in to BCSO Media. Mr. Barnes information was added to the case report.
