NARRATIVE

Section 1: Narrative

On Sunday, November 17, 2024, at approximately 1600 hours, I responded to Holmes Regional Medical Center (HRMC), located at 1350 Hickory Street, Melbourne, Florida, 32901 in reference to a juvenile who was injured during the rodeo at the Space Coast State Fair located at 5775 Stadium Parkway, Melbourne, Florida, 32940, on November 15, 2024, and his health was deteriorating.

Upon arrival, I made contact with the registered nurse in ICU, who advised when Mr. Walker Smith was brought in, he was stable and talking as normal. She stated at approximately 0300 hours on November 17, 2024, Walker's health began to deteriorate, and he was unable to communicate any longer. She stated Walker's oxygen levels became extremely low, and carbon monoxide levels were high, due to him not respirating properly. The nurse stated due to the condition Walker was intubated, sedated and placed on a ventilator, and his condition is currently unstable. The nurse informed me that Walker currently has two collapsed lungs.

While at the hospital, I made contact with DCF investigator, Lyrika Evans, who was conducting an investigation due to Walker being a minor. She advised, Walker's girlfriend, Ms. Talor Heidt (Involved) signed a waiver for Walker to ride the bull with verbal consent from his mother, Ms. Sabrina Smith (Involved) through the telephone, however, Ms. Smith stated she never gave consent.

I then spoke with Walker's father, Mr. David Smith (Involved), who clarified and stated Walker was part of the rodeo for the fair, and is a professional bull-rider. Mr. Smith stated due to Walker being over the age of fifteen, neither parent needed to sign any waivers or consent forms for Walker to participate in the rodeo, but they were not aware Walker was participating in this rodeo until they received a phone call that he was in the hospital.
