#### **NARRATIVE**

Section 1 – Narrative

On Sunday, November 17, 2024, at approximately 1443 hours, I received a phone call from Deputy Santiago Leme ID# 4634. The call was in reference to an Injured / Ill incident that I observed while on an off-duty detail at 5775 Stadium Parkway, Melbourne, Brevard County, Florida, 32940, on the evening of Friday, November 15, 2024.

Deputy Leme requested that I advise him on what I observed. I stated the following in essence.

I was working a detail at the Space Coast State Fair and was assigned to the rodeo that was located in southwest corner of the fairgrounds. While observing the crowd that was gathered to watch the rodeo, I heard the PA announcer state that one of the bull riders had been stepped on by a bull. As I approached the chute area, a lady with the rodeo team requested that I notify EMS. I notified the Communication Center immediately, and Brevard County Fire Rescue (BCFR) #48 was dispatched. I then made my way to Lake Andrew Drive to flag down BCFR so they could use the entry gate to expedite the response process. Once back at the scene of the incident, I observed the bull rider, later identified as juvenile Shawn Walker, sitting on a bench outside of the chute area. He was accompanied by other members of the rodeo team. BCFR then made contact with Shawn and began to render aid. I was informed by BCFR that they would be transporting Shawn to the Viera Hospital. Upon BCFR's departure from the scene I notified dispatch that Shawn was being transported. This concluded my involvement in this incident.
