### NARRATIVE

#### Section 1: Narrative

On Friday, November 15, 2024, Deputy K. Gobeili #4906 was working an off-duty detail at the Space Coast State Fair, 5775 Stadium Parkway, Melbourne, Brevard County, Florida, in reference to a report of a bull rider that had been injured.

Deputy Gobeili was assigned to the rodeo that was located in southwest corner of the fairgrounds. While observing the crowd that was gathered to watch the rodeo, he heard the PA announcer state that one of the bull riders had been stepped on by a bull. As Deputy Gobeili approached the chute area, a lady with the rodeo team requested that he notify EMS. Deputy Gobeili notified the Communication Center immediately, and Brevard County Fire Rescue (BCFR) #48 was dispatched. He then went to Lake Andrew Drive to flag down BCFR, so they could use the entry gate to expedite the response process. Once back at the scene of the incident, he observed the bull rider, later identified as juvenile Walker Smith (DOB:08/14/2007), sitting on a bench outside of the chute area. He was accompanied by other members of the rodeo team. BCFR then spoke with Walker and began to render aid. Deputy Gobeili was informed by BCFR that they would be transporting Walker to the Viera Hospital.

On Sunday, November 17, 2024, Agent N. Lee #4402 and I were contacted and advised that Walker Smith's health had declined in the hospital and that he had been transported to Holmes Regional Medical Center.

While on scene, I spoke with medical providers who advised to me that Walker Smith was in critical but stable condition, and likely to survive.

The crime scene consisted of the Space Coast State Fair, 5775 Stadium Parkway, Melbourne, Brevard County, Florida.
