Assistant State Attorney ANDREW CHOISSER reviewed this case and made a decision to no file this case.

REMARKS: While there may have been sufficient evidence available to support probable cause for an arrest, we would not have a reasonable likelihood of success at trial in this case. There is insufficient evidence available to prove the case beyond a reasonable doubt. There is no DNA or other forensic evidence available to corroborate the child victim. There are no eyewitnesses to any events or actions that would tend to sufficiently corroborate the child victim. The defendant essentially denied the allegations. The incident has been reported to the Department of Children and Families for investigation and intervention.
