On Tuesday, August 25, 2026, a Brevard County Sheriff's Office PSA responded to the Brevard County Fire Rescue (BCFR) Station #44 located at 3780 W. King Street, Cocoa, Brevard County, Florida, 32926. He then met with the victim, Ms. Summer Stockman, who is currently a firefighter with BCFR assigned to Station #44. She stated the following in essence. On August 13, 2025, she was notified by her credit card company that she had two (2) separate unauthorized charges on two (2) separate Capital One credit cards. Both of those charges were for the same amount of \$207.95 and had occurred at a Publix grocery store. The total amount charged was \$415.90. Mrs. Stockman assumed she was the victim of some kind of online scam or chip reading type scam. She then froze/canceled the cards immediately. She would not realize until a few hours later that her credit cards were missing from her belongings. On Tuesday, August 25, 2026, another firefighter assigned to BCFR Station #44 and on the same rotation as her was notified of fraudulent charges on their bank and credit cards, she then decided that she needed to report it. (Please see BCSO CR#2026-00262593 for further information). Through investigative means, the times and locations of the fraudulent transactions were determined.

Publix surveillance footage was collected, and a suspect was positively identified. An investigation into the incident revealed that Mr. Wesley McCormick did knowingly possess custody of two credit cards belonging to the victim. Those credit cards had been taken from the victim's custody without her consent. Mr. McCormick knew that the credit cards had been taken from the custody of the victim without her consent. At the time Mr. McCormick possessed the credit cards, he intended to impede the recovery of the cards by the cardholder and use them for his own benefit. An investigation into the incident also revealed that after obtaining the credit cards belonging to the victim, Mr. McCormick used the cards to obtain goods for himself. The total value of goods acquired by Mr. McCormick for his own use and benefit was \$400. An investigation into the incident further revealed that Mr. McCormick willfully and without authorization possessed with intent to fraudulently use personal identification information concerning the victim. Mr. McCormick did so without first obtaining consent from the victim. The victim is currently a BCFR firefighter and considered a "Public Servant". Probable cause was established for the arrest of Mr. Wesley McCormick for the following charges:

One count of Theft; Obtaining Credit Card Through Fraudulent Means contrary to section 817.60.8 Florida State Statutes.

One count of Petit Theft contrary to section 812.014.3a.

In a post Miranda interview, Mr. Wesley McCormick admitted to taking the victim's two credit cards while they were stored inside BCFR Station #44. When shown the Publix video footage of the transactions occurring, he identified himself.

Mr. McCormick was placed under arrest for the aforementioned charges and transported to the Brevard County Jail Complex without incident.
